


Health, Safety & Environmental Policy BU Man Liquid Products



The implementation, maintenance and monitoring of this policy is the responsibility of company directors who have delegated the below duties in particular to other levels of management and employees.



Maintaining and improving the HSE programme and procedures consistent with the group policy, compliant to current, new or revised local legal requirements applicable to the operations, products and activities.





Continuously measuring and reviewing HSE performance to ensure continuous improvement.



Providing the necessary finances and other resources required to audit compliance, investigate unsafe situations and incidents and to eliminate root causes.



The provision of safe machinery and equipment, the safe handling, storage and use of substances, free access and egress, safe systems of work and keeping dust, fumes and noise under control.

- Conserving natural resources in any stage of the operational process and limit the use of natural resources in all processes to the lowest achievable levels, wherever possible and practicable.
- Active participation from senior management in the HSE program by reviewing HSE performance in Management Committee Meetings.
- Recognizing companies, business units and individual employees for positive achievements, good practices and good performance.
- Regularly reviewing the HSE system polices and procedures to ensure they remain relevant and appropriate to the organization and operations.

It is the responsibility of all employees to cooperate with this policy and to look after their safety and that of others. On each MLP location, the local senior manager is responsible to supervise the coordination and implementation of this policy.
